1 The Third Interim Fee Application for Payment of Fees and Reimbursement  
2 of Expenses ("Application") filed by Squire Patton Boggs, US LLP ("SPB"), local  
3 counsel in the Dominican Republic to Thomas A. Seaman ("Receiver"), the Court-  
4 appointed permanent receiver for Defendants USFIA, Inc., Alliance Financial  
5 Group, Inc., Amauction, Inc., Aborell Mgmt I, LLC, Aborell Advisors I, LLC,  
6 Aborell REIT II, LLC, Ahome Real Estate, LLC, Alliance NGN, Inc., Apollo  
7 REIT I, Inc., Apollo REIT II, LLC, Amkey, Inc., US China Consultation  
8 Association, Quail Ranch Golf Course, LLC, and their subsidiaries and affiliates  
9 (collectively, "Receivership Entities"), came on for hearing on January 8, 2018.  
10 Appearances were as noted on the record.

11 The Court having received and read the Application, including any supporting  
12 declarations and objections filed therein, and being so advised in the matter and  
13 finding good cause, orders as follows:

14 **IT IS ORDERED** that the Application of SPB is granted.

15 **IT IS FURTHER ORDERED** that SPB's fees and costs for the Third  
16 Application Period are allowed and approved, on an interim basis, in the amounts of  
17 \$51,910.16 and \$1,789.24, respectively.

18 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to  
19 pay SPB \$51,910.16 in fees and \$1,789.24 in costs from assets of the receivership  
20 estate, which amounts reflect an interim payment of 100% of the allowed fees and  
21 costs.
